
# Starting a new claim with ODR

New claims can be commenced on eBRAM's ODR Platform if the parties have agreed (before or after the dispute has arisen) to resolve their dispute by mediation / arbitration using ODR, or under eBRAM Rules.

#### **Dashboard**




- See case status and financial information at-aglance
