Any representation that creates an impression of official approval or that a drug is approved or is legally marketable because of registration or listing is misleading and constitutes misbranding." As your U.S. Agent and Registrant Contact, Registrar Corp will continue to serve as a communications link between the U.S. FDA and your company for your electronic submissions.
